All prospective applicants for membership of the Dingley Village Men's Shed Inc. are welcome, and must be informed of the following information prior to submitting their application form.

- Until you are accepted as a member, you remain a visitor to the shed.
   As a visitor, you <u>must</u> sign in the Attendance Book for each attendance you make at the shed.
   Also, you must obtain and wear a VISITOR Badge (available in the box next to the Attendance book) at all times whilst at the shed. Please return the VISITOR Badge to the box prior to leaving the shed each day.
- Please complete the attached application form, clearly completing <u>all</u> items.
  You can leave the completed application form at the shed office, or if alternatively obtained from our website; print, complete and submit the form in PDF format via email to <u>admin@dvms.org.au</u>
  PLEASE NOTE: If the form is not completed satisfactorily i.e., items are illegible or incomplete, your application may be rejected! Please do not hesitate to ask if you require assistance.
- 3. Please DO NOT attempt to pay a membership fee prior to your application being approved by the DVMS committee of management. You will be notified of your acceptance in due course (generally 3-4 weeks) and also when you should pay your membership fee. During this time, you should regularly attend the shed whilst waiting to be accepted e.g., once or twice a week with at least a minimum of 3 attendances over 3 weeks.
- 4. For a nominal cost as indicated in the kitchen area, visitors are invited to enjoy a cuppa with members in the Amenities shed.
- 5. All visitors are <u>not permitted</u> to enter or remain in the Workshop at any time, unless accompanied by a DVMS member. If the member accompanying you leaves the Workshop, you <u>must</u> also leave the Workshop. Failure to observe this requirement may lead to a refusal of your application!
- 6. Upon acceptance of your membership application and payment of the membership fee, you will be issued with a copy of the current DVMS Membership Booklet. The booklet contains information relevant to your membership of the DVMS. Please take the time to become familiar with its contents. You will also have your photo taken for our Pictorial Membership Display Board.
- 7. Membership fees are due for renewal annually on **1**<sup>st</sup> **January** and should be paid by this date. **Note:** Late payments may incur a penalty fee.
- 8. A financial member is eligible and encouraged to take part in various shed activities, including activities that support the DVMS day to day operations. However, the use of workshop machinery must not be attempted by you until you receive satisfactory individual instruction and are deemed competent on the safe use and functionality of each machine that you may wish to operate. This regulation is required regardless of your work history, knowledge or experience previous to becoming a DVMS member.
- 9. As a DVMS member you may be asked to support or be involved in a DVMS fund raising activity or event. These occur from time to time. Please give these activities and events your full support. The DVMS can only be as good as its members allow, particularly via their participation.
- 10. The Dingley Village Men's Shed is located in Parks Victoria's Braeside Park. Within Braeside Park, vehicle speed <u>must not</u> exceed <u>20KPH!</u> You are expected and required as either a visitor or a DVMS member to adhere to this regulation, without exception!
